## VICTOR TOWNSHIP BOARD MINUTES- November 1, 2005 (Accepted)

Call to Order and Pledge

The regular monthly business meeting of the Victor Township Board was held at the Township Hall, 6843 Alward Road, Laingsburg, MI 48848. Supervisor Warren Malkin called the meeting to order at 7:00 p.m. The pledge to the flag was given.

Roll Call of Members

Members present: Michelle Wilsey, Warren Malkin, Donald McDonald, Dan Morris, Duane Ginther. Other governmental representatives in attendance: Claude Vail, Clinton County Commissioner. Eight (8) citizens present.

**Public Comment** 

Round Lake Environmental Corporation is meeting tomorrow night. They will be discussing a special assessment district for lake improvements. An election is scheduled Tuesday, November 8 for the Clinton County RESA. Only those Victor Township residents in the Bath, St. Johns and Ovid-Elsie school districts are eligible to vote.

Agenda

Ginther moved, second by Malkin and motion carried to approve agenda.

Minutes and Treasurer Report

Minutes of the October 4, 2005 board meeting were accepted as printed. The Treasurer's report was accepted subject to audit.

Approval of Bills

Malkin requested advance payment of \$28,000 (approximately half) of Victor Township's share of the #614 Laingsburg Branch #1 Intercounty Drain assessment. The purpose is to lower the principal on the note and improve the interest rate for property owners and the township. McDonald moved, second by Ginther and motion carried to authorize \$28,000 payment on the Victor Township at-large payment for the Laingsburg Drain. McDonald moved, second by Ginther and motion carried to make the following budget adjustments: increase account 101-445-803-00 Drains by \$25,730.40 and decrease account 101-890-999-00 Contingency by \$25,730.40. McDonald moved, second by Ginther and motion carried to pay submitted bills.

## **Reports**

Planning: Resignation was submitted by planning commission member Robert Furman. McDonald moved, second by Wilsey and motion carried to accept the resignation. The Board expressed appreciation for Mr. Furman's many years of service to the community. The planning commission met in October but because of a lack of quorum no official action was taken. The chairman changed the next meeting date from November 23 to November 30, 2005 due to the Thanksgiving holiday. Duane Ginther requested that the planning commission be allowed to hire someone to take minutes and provide some administrative support. McDonald moved, Ginther second and motion carried to authorize the planning commission to hire an assistant with rate and hours to be set by the planning commission with said payments and related costs not to exceed planning commission budget.

Commissioner Vail reported that the MTA meeting is scheduled November 9, 2005, 7:00 p.m. at the Clinton County Courthouse. Clinton County adopted a resolution opposing House Bill 5124 due to potential budget impacts. The County adopted a new building code. Residential building permit fees will decrease approximately 5%. The new health department facility is projected to be completed by April 2006. Phase I of the Clinton County fairground project is scheduled to be completed by July 2006.
