## VICTOR TOWNSHIP BOARD MINUTES- February 7, 2006 (Approved)

Call to Order and Pledge

The regular monthly business meeting of the Victor Township Board and the initial public hearing on the budget was held at the Township Hall, 6843 Alward Road, Laingsburg, MI 48848. Supervisor Warren Malkin called the regular meeting to order at 7:00 p.m. The pledge to the flag was given.

Roll Call of Members

Members absent: Duane Ginther. Other governmental representatives in attendance: Claude Vail,

Clinton County Commissioner. Seventeen (17) citizens present.

Agenda

Morris moved, second by McDonald and motion carried to approve agenda as printed.

Minutes and Treasurer Report

Minutes of the January 3, 2006 board meeting were accepted as printed. The Treasurer's report was accepted subject to audit.

Approval of Bills

McDonald moved, second by Morris and motion carried to pay submitted bills, check #s 9772-9792 in the amount of \$6,011.70.

Reports

Planning: The township master plan discussion was tabled until the county provided further information on the process of updating land use plans. Administrative Policies and Procedures for Budgeting and Education for the Planning Commission were developed and will be sent to the Township Board for approval. A budget of \$2250 was submitted to the Board. Bear Creek Kennel variance enforcement was discussed. The west building will no longer be used as it is in violation of the approved variance. Planning Commission recommended approval of the Fox variance conditioned on the approval of the Health Department approving a new sewage/septic system. The Planning Commission recommended approval of the site plan for the Chadwick gravel pit with the requests to the Petitioner to have a flowering type seeding for the berms along the boundaries of the area and to request 5-7 foot trees of native stock to be planted along Alward Road. Pete Preston reported that clean up of the property west of K's market had been ordered. Next meeting February 22, 2006, 7:00 p.m., Victor Township Hall. Fire/CAF&R: Jean Bond, Bingham Township has been hired as Administrative Assistant to CAFR. Next meeting is February 14, 2006, 4:00 p.m. Station #1.

Historical Society: Next meeting is February 8, 2006, 7:30 p.m., Victor Township Hall. Meetings are held the 2<sup>nd</sup> Wednesday of each month – public welcome.

**Clinton County Officials** 

Commissioner Vail reported that the Victor Township flag would be presented to the County Board of Commissioners at the meeting scheduled February 16, 9:00 a.m. Mid-Michigan Environmental Health Division would be building new facilities. The County is working on purchase of rail ROW in Ovid and establishing routes in cooperation with local businesses and property owners. Probate court costs are rising and cost containment and budgeting strategies are under consideration. Jim Weaver was appointed to the Clinton County Board of Appeals. Possible future millages for green space/purchase of development rights and childcare funding have been discussed.

## **BUDGET PUBLIC HEARING**

The meeting recessed at 7:18 p.m. for an initial hearing on the proposed budget for fiscal year 2006-2007. Supervisor Malkin presented the proposed budget for the township. Township Board members identified several areas of adjustment to be considered in the final budget. A member of the public requested an explanation of what election costs included. Wilsey explained the costs were

associated with administration of elections and some of the variables that impacted budget projections. A final public hearing on the budget is scheduled Tuesday, March 7, 7:15 p.m., Victor Township Hall. The budget hearing closed at 7:21 p.m.

New Business

PC-06-06-SP Final Commercial Site Plan (Chadwick Gravel Pit). Jim and Lisa Snider presented a letter outlining concerns of neighborhood residents regarding final site plan approval of the gravel pit. The letter was also presented to the Victor Township Planning Commission. Board members McDonald and Wilsey raised several questions regarding compliance of the submitted plan with the County Zoning Ordinance. An analysis prepared by the Community Development was reviewed. McDonald moved, second by Morris and motion carried to advise the Clinton County Planning Commission of a list of Board concerns including Ordinance issues and site plan specific issues, and Township Planning Commission recommendations that should be satisfied prior to approval of the final site plan. The list is attached and included by reference to these minutes.

ZC-01-06 VR 5912 E. Round Lake Road Variance – McDonald moved, second by Morris and motion carried to recommend approval of the variance conditioned on Mid-Michigan Health Department septic system approval.

Tax Receipts Policy Resolution - Motion offered by McDonald, second by Morris, to adopt a resolution to discontinue mass mailing of tax receipts effective April 1, 2006. Upon a roll call vote the following voted yes: Morris, Malkin, McDonald, Wilsey. The following voted no: None. The following were absent: Ginther. The Supervisor declared the motion carried and resolution adopted.

Round Lake Property Owners: Requests the township initiate review of language and procedures for special assessment district for weed harvesting from Round Lake. McDonald moved, second by Wilsey and motion carried to move forward with the special assessment district with the understanding that costs incurred by the township for special assessment review and activities will be recouped in the special

assessment as provided by law or, if not successful, reimbursed by the Round Lake Environmental Corporation.

Tax Refunds of less than \$5.00 Policy Resolution: Motion offered by McDonald, second by Wilsey, to adopt a resolution to discontinue reimbursement of tax overpayments if the amount of overpayment is less than \$5.00 unless requested by the taxpayer. This policy is effective April 1, 2006. Upon a roll call vote the following voted yes: McDonald, Wilsey, Malkin, Morris. The following voted no: None. The following were absent: Ginther. The Supervisor declared the motion carried and resolution adopted. Poverty Exemption Policy Resolution: Motion offered by Malkin, second by Wilsey to adopt the Victor Township 2006 Poverty Guidelines Resolution and Poverty Guidelines attached and included by reference as part of these minutes. Upon a roll call vote the following voted yes: Malkin, Wilsey, McDonald, Morris. The following voted no: None. The following were absent: Ginther. The Supervisor declared the motion carried and resolution adopted.

Township Office Regular Business Hours: The supervisor requested that Township Board Officers post their regular office hours.

Fire Services Charges: Malkin moved, second by McDonald and motion carried to enforce Ordinance 19.2 Victor Township Fire Service Charges Ordinance, Section 2. This section establishes fees and provides that "All persons receiving fire protection services within the Township shall remit the sum of Five Hundred Dollars (\$500.00) for each incident requiring service..." (Note: some exceptions apply). Enforcing this section assures that all people are treated equally with regard to fire services charges in the Township.

Motion by Morris, second by Wilsey and motion carried to extend adjournment from 9:30 p.m. to 9:45 p.m.
