Call to Order and Pledge

The regular monthly business meeting of the Victor Township Board was held at the Township Hall, 6843 Alward Road, Laingsburg, MI 48848. Supervisor Warren Malkin called the meeting to order at 7:00 p.m. The pledge to the flag was given.

The Treasurer's report was accepted subject to audit.

McDonald moved, second by Morris and motion carried to approve bills in the amount of \$6077.94, checks 10020-10039.

Reports

Planning: The planning commission met January 31, 2007. Clinton County is preparing an overlay of wetland for the township. Commission voted to recommend approval of rezoning request PC-10-07 MA from A2 to A3. Next meeting of the Victor Township Planning Commission is February 21, 2007, 7:00 p.m., Victor Township Hall. Ginther moved, second by Morris and motion carried for Victor Township to recommend approval of rezoning request PC-10-07 MA.

Economic Development: Clinton County Economic Development Steering Committee has been formed and work on creating an Economic Development program is underway. Chris Thelen, CMS Energy was appointed Chair of the Organzational Subcommittee and Dave Brown, Firstbank of St. Johns is chairing the Finance Subcommittee. The Rural Enterprise Innovation and Entrepreneurs Group met on January 31 at Victor Township. Over 40 people attended and discussed ideas for developing and expanding rural enterprise in our local region. The next meeting is February 28, 2007, 7:00 p.m. at House in the Woods Bed & Breakfast (Olive Township). Guest speaker will be Tom Kalchik, Associate Director, Product and Market Development Agent, MSU Products Center for Agriculture and Natural Resources. He will discuss business planning strategies and resources for microenterprise.

## **BUDGET PUBLIC HEARING**

The meeting recessed at 7:20 p.m. for an initial hearing on the proposed budget for fiscal year 2007-2008. Supervisor Malkin presented the proposed budget for the township. The primary discussion was on the proposed road projects. Completing all of the scheduled maintenance projects would require using \$111,000 of reserve funds. Options for modifying the budget and consideration of using the reserve while maintaining overall fiscal integrity were discussed. Commissioner Link asked if anyone went out and looked at the roads. Wilsey responded yes and explained that the board participates in a physical road tour with the County Road Commission each year and sometimes multiple times a year. She also explained that the citizen road committee comprised of individuals living in different areas of the township undertook an extensive assessment of township roads and road data over the past year. This provided input for the road plan and recommended priorities for road maintenance. Supervisor Malkin noted that road counts are also done by the County Road Commission and considered in the road planning process.

## Clinton County Officials

County Commissioner: Commissioner Link reported that the county is moving forward with the joint purchase of property for a recreational site at Dewitt and Colony Roads. The board received a preliminary draft of a safe county initiative and anticipate a request for a bond proposal in the spring. The county planning commission approved a variance for a retail greenhouse on Hollister Road. The county health department dental clinic received donated equipment and a grant to help fund operations.

Clinton County Deputy Sheriff Alward reported that reports of breaking and entering are down and snowmobile and quad complaints are up.
