# **VICTOR TOWNSHIP BOARD MINUTES- March 31, 2009 (Tentative)**

Call to Order and Pledge

The regular monthly business meeting of the Victor Township Board was held at the Township Hall, 6843 Alward Road, Laingsburg, MI 48848. Supervisor Warren Malkin called the meeting to order at 7:00 p.m. The pledge to the flag was given.

#### Reports

Planning: Letter regarding Salver SUP was discussed. The planning commission will not send the letter due to the time that has passed. There was discussion of the possible building project on Centerline Road but nothing is moving forward at this point. Tenlen complaint is pending with the county. Next meeting scheduled April 29, 2009, 7 p.m., Victor Township Hall.

CAFR: Next meeting is April 14, 2009, 7 p.m., Station #3 (Victor).

Historical: April 15, 2009 meeting cancelled. The meeting may be rescheduled later in the month. Clinton County Economic Alliance - Chris Thelen has taken over as the Acting Chairman. Dave Ivan was recognized for his contributions. Marilyn Thelen has been appointed to the board. CCEA has sponsored or marketed several workshops and seminars for businesses and entrepreneurs. They are also focusing on retention visits, web site development, and training.

## **Clinton County Officials**

Clinton County Commissioner Adam Stacey – Reported that the airport incinerator permit was denied by the County Board of Commissioners. A revised request including restrictions on importing trash may be brought before the board.

Grant proposal to add acreage to Motz Park has been approved. Development will occur over a number of years.

Deputy Alward was not in attendance.

#### **Unfinished Business**

Township Insurance – Proposals from The Chapman Agency and Burnham and Flower were reviewed. Deductibles were comparable. Public Official bonds higher in Chapman. Cost to increase official bonds in Burnham & Flower proposal was estimated at approx \$150. Property values for Burnham & Flower were higher than Chapman. Cost to increase property coverage to comparable levels by Chapman was estimated at approx. \$75. Chapman Agency stated that claims history related to vandalism at Blood Cemetery would not impact the cost of insurance premium quoted. Aggregate limits and occurance coverage were discussed. Chapman included aggregate limits and Burnham & Flower did not. Both included occurance coverage. Following the review, the Burnham & Flower quote was lower than Chapman for comparable coverage. Wilsey moved, second by Malkin and motion carried to approve the Burnham & Flower insurance proposal for FY 2009-10 with Wilsey signing the contract.

Sale of light fixtures – Malkin moved, second by Wilsey and motion carried to offer the removed light fixtures for \$5 apiece.

Concession stand – Boy Scouts have been looking at opening the concession stand at Victor Township pavilion. They have invested approximately \$240 for a 6 week food service license. They would like to have a refrigerator and use three tables in the concession stand. Township would pay for electricity. Malkin moved, second by McDonald and motion carried to allow Boy Scouts to use the concession with a refrigerator and tables. The need to discuss clean up responsibility around the concession stand area was noted.

Wilsey discussed the recreation plan update. It will be on the agenda next month.
