Moved by Willoughby, supported by Sayles, to approve the agenda as amended omitting Investigation from New Business as Wall prefers to move forward and has withdrawn request for investigation. All in favor, motion carried.

Moved by Wall, seconded by Willoughby, to approve the minutes of December 5th, 2017 as amended (changing LES to LSW). All in favor, motion carried.

Malkin accepted the Treasurer's report to be placed on file, subject to audit. Willoughby explained report in detail. Moved by Sayles, supported by Wall to approve request for a check for the previously approved budget amendment to cover road funding. All in favor. Motion passed.

Moved by Willoughby, supported by Wall, to pay the accounts payable in the amount of \$12,480.24 using check numbers, 26860-26884. All in favor, motion carried.

Moved by Willoughby, supported by Wall, to pay the payroll in the amount of \$5,156.46 using check numbers, 11837-11888. All in favor, motion carried.

LSW Representative Wall reported business as usual.

Items of public interest:

Willoughby suggested the three contacts for the county emergency services be the supervisor, clerk and treasurer. Discussion of the fire hall lights took place.

Correspondence:

Smith discussed a DEQ General Permit which was sent to the Victor Twp. Planning Commission and placed on file. Smith discussed a police report was created to document soccer field vandalism, the Michigan State Police was in contact with the driver who drove on the fields. Inspection of the fields will take place in the spring and damages will be the responsibility of the driver who caused the damage.
